Sub: Decision on Allowing Employees of Prasar Bharati recruited after 05.10.2007 to become Members of recognized Association under CCS(RSA) Rules, 1993-Withdrawal of this Secretariat letter dated 09.09.2015 regarding.

Kind attention is invited to this Secretariat letter No. Misc-1/112/2011-PPC(pt2) dated 09.09.2015 (Copy enclosed) wherein employees recruited after 05.10.2007 (Prasar Bharati Employees) had been allowed to join existing Associations, recognized under CCS(RSA) Rules, 1993, in their distinct category for the purpose of raising their demands/issues, if any.

2. The subject matter has been re-examined in view of various representations received from different quarters regarding inclusion of Prasar Bharati employees as Members of Association under CCS (RSA) Rules, 1993. Revisiting the Ministry of I&B letter dated 06.08.2015 and opinion of Sr. Standing Counsel , Prasar Bharati, the Competent Authority is of the view that inclusion of PB employees, as defined under section 11 (5) of the PB Act, 1990, as Members of the Association during fresh recognition, may give rise to legal complications. Further, the Rules may become unworkable especially with respect to the provisions regarding recognition, withdrawal of recognition, verification of membership, etc .

3. In view of the above, it has been decided to withdraw the letter No. Misc-1/112/2011-PPC(pt2) dated 09.09.2015 with immediate effect. Accordingly, the ongoing re-verification of existing associations shall not take into consideration inclusion of employees as defined under section 11(5) of Prasar Bharati Act.

4. Separate instructions shall be issued to enable employees of Prasar Bharati recruited after 05.10.2007 to form their own associations.
